This form should be completed by a person who transfers by consigning to a postal service, courier or other third party, Eastern Caribbean and/or foreign currency to be taken into or out of Antigua and Barbuda **and** the currency involved is of a total value of **\$10,000 U.S. or more or its equivalent in other currency**.

"Currency" means cash or bearer negotiable financial instruments.

Reporting of transfers of currency valued at \$10,000 U.S. or more, or the equivalent in other currency into or out of Antigua and Barbuda is required by law under Section 18 of the Money Laundering (Prevention) Act 1996 as amended.

Currency not reported according to sections 18(1), (2) and (6) of the The *Money Laundering (Prevention) Act [No. 9 of 1996] as amended* may be seized by law enforcement officers.

The Money Laundering (Prevention) Act 1996

The Money Laundering (Prevention) Act [No. 9 of 1996] as amended makes provisions under section 18 for currency reporting in order to assist law enforcement in the detection of serious criminal activity, including money laundering, drug trafficking and organised crime.

Use of the information reported

Reports received by the Comptroller of Customs will be forwarded to the Supervisory Authority under the Money Laundering (Prevention) Act 1996 and analysed by the financial intelligence unit. The information reported is confidential.

Penalties

There are penalties for failure to lodge a report with the Comptroller of Customs or a customs officer assigned for duty at the point of mailing/shipping or receivng currency or supply full and correct information. The penalties include:

- imprisonment for a period not more than two years; and/or
- a fine of up to fifty thousand dollars; and
- the confiscation of the cash or negotiable instruments being transported.
